## **Privacy Policy**

### 1 Purpose

Alta Zinc Limited's (Alta Zinc or the Company) is committed to respecting the privacy of personal information (PI) collected in accordance to applicable privacy laws. By providing the information to AZI, subscribing to email alerts or contacting the Company via the website, you are consenting to personal information contained being transferred within AZI and its share registry, AZI's related bodies corporate, agents and contractors and third-party service providers (including mailing house and professional advisors) and to ASX and regulatory authorities. You also consent to such personal information being processed to provide services and appropriate administration for you.

The Company places importance on the security of information held. Information stored can only be accessed by those entrusted with authority by AZI.

#### 3 Cookies

AZI's website uses cookies to provide the best possible experience. Cookies are small pieces of data store on a site's browser. The cookies are typically used to keep track of the settings users have selected and actions they have taken on a site. There may also be third-party apps or integrations like Google Analytics, Facebook Ads which may also place additional cookies on the website.
